2. Procurement subject information

This tender will understand the procurement for machine:

- **Pad Printer – Procurement number 111/22**

The procurement subject includes machine delivery, machine installation and employee education for working with machine. Offered machine must be new.

3. Technical specification

The technical specification of the Pad Printer machine is described below.

Product types, standards or any other characteristic mentioned in specification will be referenced but will understand „equivalent“ characteristic of supplier.

Proof of equivalence is delivered by the Tenderer within the offer, by appropriate means, such as technical specifications, technical data and similar. The proof of equivalence will be basis for evaluating whether the offered machine have the prescribed features.

Specification:

- 4 printing colors
- Closed system for color printing
- 3 servo motors with pneumatics
- Automatic pad cleaning system
- Drying system (hot wind fen)
- Printing speed min 400 cycles/hour
- Cliches size 125 x 250 mm
- Possibility of single print
- Print thrust min 1.400 N
- Remote control pedal
- Maximum height of the piece to be printed 300 mm

- Pad descent adjustment from keyboard
- Program memorizing
- Single automatic cycle program
- High stand
- Additional equipment (spare parts)
 - Inkwell with ring Ø 90 mm – 4 pieces
 - Ceramic knives for removing color Ø 90 mm – 4 pieces
 - Ceramic knives for removing color Ø 110 mm – 4 pieces
 - Ceramic cliches 125 x 250 mm – 10 pieces
 - Printing pads Ø 72 mm, height 60 mm – 4 pieces
 - Printing pads Ø 90 mm, height 60 mm – 4 pieces
 - Printing pads Ø 86 mm bottom, Ø 58 mm top height 50 mm – 4 pieces

Due to organization of project realization, delivery of Pad Printer must be maximum **90 days** after Purchase Contract signing.

4. Delivery

Place of delivery will be address of KB d.o.o. company: **Vilka Novaka 6, 42209 Sračinec, Croatia.**

The contract will be based on tenderer offer and technical specification in this tender. In case that tenderer makes offer with better condition than requested in Tender, better condition for Contracting Project Promotor KB d.o.o. will be part of Contract.

After finishing the tender, the company will analyze offers from potential suppliers and make a decision in the next 15 days. After decision, KB d.o.o. will inform tenderer about decision and will prepare Contract to tenderer who win the tender.

Contract have to be signed 15 days after information to tenderer.

5. Education

After machine delivery and installation, Tenderer will ensure education for work with machine.

6. Warranty

The warranty must be at least **5 years (60 months)** after installation of machine.

Tenderer have to be ready to react in maximum 3 days after service request.

7. Selection and Award criteria

Award will be based on the **Most Economically Advantageous Tender (MEAT)** and will be based on:

- DT - Delivery time – Delivery time is participating in assessment with 10%
- P – Price – Price will be valued with 90% in assessment.

Calculation will be: **MEAT = (DT/90)*10% + (P/average price)*90%**

Lowest MEAT will be Awarded.

Tenderer have to proof technical specification of each machine and have to deliver machine in accordance with offer.

Tenderer have to proof After-Sales Service Partner with Contract or Certified authority.

Related document has to be applied by tenderer.

8. Tendering

Offer delivery

Tenderer have to deliver offer with Application Form in Appendix for machine it applies and document which proof compliance with Tender request. Tenderer have to apply price with and without VAT.
