Purchase Decision

- The Tender Announcement has been sent to three possible Tenderers by email and the Tender Announcement has been published on official website www.k-b.hr. Two companies, has send their Applications on time, Europapier Dipa d.o.o. (email from 28th December 2023, 15:17) and IGEPA PAKO d.o.o. (email from 4th January 2024, 08:50). Both Applications met all the conditions from Tender Announcement.
- Award of the Tender is based on the Most Economically Advantageous Tender (MEAT) and is based on:

W – Warranty – Warranty is participating in assessment with 10% P – Price – Price will be valued with 90% in assessment.

Calculation will be: MEAT = (12/W)*10% + (P/average price)*90% Lowest MEAT will be Awarded.

Results of the Tender based on the Most Economically Advantageous Tender (MEAT):

Europapier Dipa d.o.o.

MEAT = (12/24)*10% + (49.790,00€/50.290,00€)*90% = 0,94

IGEPA PAKO d.o.o.

MEAT = (12/12)*10% + (50.790,00€/50.290,00€)*90% = 1,01

Since company Europapier Dipa d.o.o. fulfilled all the conditions of the Tender and has the lowest MEAT, the commission for Tender for UV Printer machine – number 20/23 decided to accept the offer of Europapier Dipa d.o.o.

• The unsuccessful tenderers have a possibility to have an insight into the procurement documentation three (3) days after notification on the results of tendering has been made available to tenderers.

- In case unsuccessful tenderers believe their tender has been unjustifiably rejected, or inappropriately rated, they may submit an appeal to a Fund Operator electronically (using the following email address: cro.innovation@innovationnorway.no), within five (5) days from being notified. Appeal must be written in English, appropriately argued and supported by evidence, as appropriate. At the same time, copy of appeal must be sent to Contracting Authority (KB d.o.o.), who must send the entire package of Procurement Documents to Fund Operator immediately, and may provide its counter-arguments to Fund Operator within five (5) days from receipt of copy of appeal.
- Based on the analysis of procurement documentation, and arguments of both parties, Fund Operator makes the decision within ten (10) days from which appeal has been submitted. The Fund Operator's decision is final.
